**CURB CUT/ACCESS PERMIT**

**Notice:** This permit is issued in accordance with Title 19 V.S.A., Sections 1111 and 1108, relative to all highways within the control and jurisdiction of the Town of Moretown. The issuance of this permit **does not** release the applicant from any requirements of statutes, ordinances, rules and regulations administered by other governmental agencies.

This permit will be effective upon compliance with such of these requirements as are applicable and continue in effect for as long as the present land use continues. Any change from the present land use will require a new permit. This permit is issued subject to the directions, restrictions and conditions contained herein and any attachments hereto, and covers only the work described in this application, and then only when the work is performed as directed. Violations are subject to penalties set forth in Title 19 V.S.A. Sections 1111 and 1108, fines of not more than \$100 for each offense plus actual costs of repairing damage to highway, to be recovered in a civil action, in the name of the Town of Moretown.

Directions, Restrictions & Conditions: ***The landowner is responsible for maintaining and replacing any culverts installed in the town right-of-way.***
