- 9. Shall the voters of the Town of Moretown vote the sum of \$1,068,802.00 for the support of the town, for the fiscal year ending December 31, 2013, for any operating expenses and other obligations? Voting to be by Australian ballot. Polls open from 7:00 a.m. to 7:00 p.m. YES 249 NO 82
- 13. Shall the voters of the Town of Moretown vote to set aside the sum of \$10,000.00 for the repair and upkeep of the bridges of the Town? Voting to be by Australian ballot. Polls open from 7:00 a.m. to 7:00 p.m. YES 286 NO 43
- 14. Shall the voters of the Town of Moretown vote to approve spending an amount not to exceed \$5,000.00 for law enforcement, to supplement the \$5,000.00 already in the budget? Voting to be by Australian ballot. Polls open from 7:00 a.m. to 7:00 p.m. YES 206 NO 112
- 15. Shall the voters of the Town of Moretown authorize its Select Board to divide the revenue from the Moretown Landfill Inc., so that 52% is deposited into the General Operating Fund to lower the 2013 tax rate, 40% is deposited into the Savings Reserve Fund, and 8% is deposited into the Capital Reserve Fund?
