We went around and made introductions as board members, Friends and a patron. We spent time thinking and writing down our individual responses to the four questions. We then spoke with a person next to us about our responses.

After, we put our post its on the posters, we looked at them and had this discussion:

- In what context do we mean sustainable? Do we mean enduring? Sustainability can mean What is our growth rate including meeting the needs of patrons. A bigger question is what little resources we have to support where we want to grow to. Focus on meeting the needs of patrons. How do we meet the needs of the Select Board to have more resources? What data can help support?
- Who comes to the library? Who doesn't come to the library? Is it a part of sustainability to reach the people who don't use the library? Those who don't come to the library Town Report one page might be the only thing they know.
- Friends are thinking of sending a letter to all Moretown residents asking them to show support as an annual campaign to solicit donations based on what Friends are doing and include programming.
- Geography of the Town is a challenge to who library serves (in proximity)

- Safety issue of the Town Hall with no crosswalk and so many issues needing renovations
- Will branding be an outcome of our Strategic Planning? Yes, how about early summer
