4. Backcountry Alliance Presentation - Steve Sharpe

BCA as an organization is focused on helping educate and support land access for VT residents & visitors to participate in a variety of snow sports throughout the state. The local chapter would like to partner with the town to host an event. They have requested support from the Rec Committee to host an event for backcountry gear education, on snow techniques & skills, and general snow safety. This would likely leverage the parking area, pavilion, rec fields, and the immediate slopes just above the fields (these slopes were recently mowed in October as they have been annually in years past). Additional discussion to expand the quality and reach of skiable trails in the town forest just above the septic field. This specific topic will be included in a future meeting. Motion to give the BCA support from the Rec Committee to seek permission from the select board to define and host an event focused on backcountry winter sports training events. Hearing none, all in support, no nays, approved.
