Meeting was called to order by John at 6:00 pm.

Public Comment: Rae was present to give an update on FEMA. The total that has been submitted to them is \$335,630 and they have approved \$70,667, so far. He has a meeting with the new FEMA rep on Tuesday. There is still resurfacing that needs to be done on three of the roads. He also gave an update on the parking lot, the road crew will be starting the excavation on June 24th, the whole project is projected to be complete by August 16th. The paving and concrete bids went out and the due back deadline is May 10th. The Methodist church is repainting this summer and needs the south entrance to be done first. Poulin will be back next week doing some warranty work on the ditching behind the school as well as more work on the ponds. It will not fix the Fox Farm culvert issue, the land owners are replacing one culvert and having the other one flushed out. Discussion was had on the lilac tree out by the monument that Poulin moved during the project last year. It tipped over and the question of it surviving was talked about. They will stand it back up and reset it, see if it takes root.

Darlene with Mad River Consulting asked about doing the platform for the town website. Chuck Burt has been being reimbursed for this and she asked to take it over, streamlining the work that she has been doing. The SB agreed to go ahead and allow her to do that. Sasha will get with her on it.

John let everyone know that he had been contacted regarding a garbage issue on Moretown Common Road and asked that Sasha contact Dick Valentinetti.
