Meeting Minutes

Emily Hackett discussed the status of the archeological review and test pits. The State has 30 days to reply.

Per Emily, the grant is almost ready for submission. When it's ready, it come from Renae Miller (one of their grant writers) and will go to the Chair of the Selectboard, and it will be copied to Clark for the Committee. We all need to read it. It will need to be signed electronically. Emily will give us a heads up when that gets sent.

Per Emily, the "priority list application" is due in January 2024 (sooner than we thought). Clark indicated that this is not a very onerous process.

There was a discussion about the slowness of this process, and frustration expressed.

David suggested that we create a list of the properties that could be served by this project, and is wondering if we should do some outreach to them, including people who currently "on the edge" of the service area. Clark will ask Cherilynn for a spreadsheet/list of properties that fall within the possible service area.
